Commission

Each application is different and the level of commission is based upon many different factors, so it can be varied.

We pay our agents a commission on any successful applications that have been referred through by themselves.

We offer between 30 - 50% of our commission for successful applications. Below are some examples of average estimated income figures (based on 30% commission).

I hereby confirm that the information given is true and correct. I consent to:

My personal data being included on a computerised database for company use. I understand that my role is as an independent agent therefore:

- I am not directly employed by Heart Finance thus am responsible for my own tax and National Insurance. 1.
- 2. I must respect the name and assets of Heart Finance and thus must introduce myself as an independent agent of Heart Finance. Heart Finance grants the agent the right to operate the business as a self employed agent, to collect personal details and pass them directly on to Heart Finance for processing.
- 3. I must observe all national, regional and local laws of the territory with regards to the operation of the business. This may include laws such as advertising restrictions and conditions required on promotional material.
- 4. I will not disclose to third parties the know-how provided of Heart Finance.
- 5. The agent is required to provide Heart Finance with details of all marketing carried out by the agent.
- The agreement shall remain in force for 5 years from the date of signature by the agent unless the agent 6. wishes to with draw by providing written notice of 2 weeks.
- 7. During the term of the agreement the agent must comply with the training manual provided and any relevant updates provided at all times.
- 8. The agent must deal with all customer complaints promptly and in accordance with Heart Finance. Any complaint unable to be resolved under these terms must be notified to Heart Finance immediately.
- 9. The agent agrees to indemnify Heart Finance against all damage, loss or liability suffered by Heart Finance as a result of the actions or omissions of the agent whilst operating under Heart Finance.
- 10. The agent can be held liable for damages or losses incurred by Heart Finance if the source of the error was at the fault of the agent.
- Heart Finance and the agent shall indemnify each other for fraud, personal injury or death caused by the 11. negligence of their employees whilst performing their duties in terms of this agreement.
- 12. This agreement shall be governed by and construed in the accordance with the laws of England and Wales or Scotland.
- I will be paid in commission only based upon the successful applications.
- Level of commission will be dependent upon many contributing factors and as an independent agent I will be emailed a monthly statement (if there are applications processing/pending) detailing applications/current status and a breakdown of the commissions due.
- Commissions will be paid out only on a successful completion and acceptance of applications and once 15. commissions have been received by the relevant lender and will be issued as agreed with Heart Finance.
- 16. Applications should have your agent ID/number on them in order for us to trace where the application has been received from.
- 17. Expenses will not be reimbursed unless prior written agreement has been obtained from Heart Finance.
- I understand that I am fully responsible for my own advertising and thus any invoices will be invoiced direct 18.
